Control the Exception Rules for your business

You're in control. ACH Exception items are generated because they meet or violate an ACH Filter Rule. Businesses can define rules at the account level for ACH activity. Then every ACH transaction presented for payment is measured against these established rules to determine if further scrutiny is needed.

EXAMPLE — ACH rules define pre-approved ACH activity for an account and can include some of the following factors:

- Originating company
- Amount range
- Debit or Credit stipulation
- Standard entry class



ACH Filtering Block: Customers are notified when transactions do not meet requirements. For example: if an ACH transaction violates an established filter.



Notifications: ACH Positive Pay delivers notifications of exceptions that require attention via email, text or mobile push notifications.

Data Comparison: Eliminate keying errors by using current exceptions or exception history to create filters with pre-filled data.



Entitlements: ACH Positive Pay Entitlements provides the use with the ability to authorize access, review exception reports and choose to pay and return decisions.

Mitigate risk with ACH Filter Rules controls

ACH Filter Rules allow users with the appropriate entitlements to manage, create, edit, and delete ACH Filter Rules. Administrators can enable additional fraud mitigation controls by filtering out unauthorized ACH transactions to provide an additional layer of security to safeguard business assets.

1 Search ACH Exception Filter Rules allow users to search on Account, ACH Company Name, Company ID, SEC Code, Amount Transaction Type and Status to find specific Filter Rules.

2 Actions provide users with the ability to edit, clone or delete each itemized rule in the search results.

3 Details link expands the ACH Filter Rule to view additional information.

4 Audit trail catalogs who created, updated, or deleted the filter rule including:

- Username
- Action taken
- Date and time stamp

Create ACH Filter Rules anytime you want

Anytime during the workflow users can decide if new rule would be more appropriate. ACH Filter Rules filters transactions from specific payers by using their ACH company ID, ACH company name, types of pre-authorizations (SEC Codes) or designated transaction amounts. ACH Filter Rules can be utilized to allow or stop ACH Transactions that pose risk factors. ACH transactions that do not meet the filter rule criteria will generate an ACH Exceptions item that can be decisioned (Pay or Return) when working ACH Exception items with ACH Positive Pay.

'Type to Filter' is available by simply typing either the Account number, ACH Company, Amount, Posted Date, Type, or SEC Code. On the mobile platform, you can quickly and easily access ACH Exceptions; however, 'Type to Filter' is available on desktop only.
